14 production of a Bank guarantee for Rs. 4,50,000/- (Rupees Four Lakh Fifty Thousand Only).

15 1. We AU Small Finance Bank Ltd. CIN: L36911RJ1996PLC011381, a Scheduled Commercial Bank under  
16 second schedule of Reserve Bank of India Act 1934, and a small finance bank under Section 22 of Banking  
17 Regulation Act 1949 having its registered office at 19-A, Dhuleshwar Garden, Ajmer Road Jaipur-302001  
18 and having one of its branch at Shop No. 40/1 & 40/2, N.H. -11 Agra Road, Khāsra No. 1423, Dausa  
19 (hereinafter called the "Bank") at the request of SANKALP VIKAS SANSTHAN , DAUSA Society do hereby  
20 undertake to pay to the Department an amount not exceeding Rs. 4,50,000/- (Rupees Four Lakh Fifty  
21 Thousand Only) against any loss or damage caused to or suffered or would be caused to or suffered by  
22 the Department by reason of any breach by the said Society of any of the terms or conditions contained in  
23 the said Agreement (बंधक पत्र).

24 2. We AU Small Finance Bank, Dausa 303303 do hereby undertake to pay the amounts due and payable  
25 under this guarantee without any demur, merely on a demand from the Department stating that the  
26 amount claimed is due by way of loss or damage caused to or would be caused to or suffered by the

34 thereto our liability under this present being absolute and unequivocal.

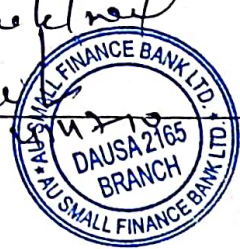
35 The payment so made by us under this bond shall be a valid discharge of our liability for payment there

70 Bank guarantee so provided.

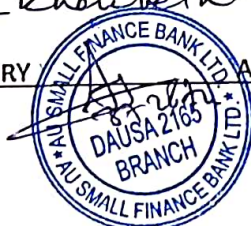
